

## The 25<sup>th</sup> Judicial District Community Corrections

The primary goal of the 25<sup>th</sup> Judicial District Community Corrections is to protect the public from victimization by offenders under agency supervision. The agency values the opportunity to assist offenders in making decisions and choices conducive to a crime free life style. It is the philosophy of the agency to assist offenders in developing the habits, skills and discipline that will facilitate long term success in the community.

The 25<sup>th</sup> JD CC was established to provide a viable, cost effective alternative in lieu of incarceration or revocation for those offenders deemed appropriate by the court according to sentencing guidelines or by state parole. The 25<sup>th</sup> JD CC provides intensive supervision as well as rehabilitative services for offenders to enhance public safety as follows:

- Community based Adult Intensive Supervision (AISP) for both male and female adult offenders.
- Assistance to offenders through referrals to social service agencies or the development of in-house programs designed to provide offenders the necessary resources to maintain a crime-free lifestyle.
- Courtesy supervision of offenders from other Community Corrections Act Programs throughout the state of Kansas.
- Screening of targeted offenders to provide input to the courts for use in sentencing decisions as determined applicable.
- Collection of court ordered restitution.
- Community service work to provide necessary and meaningful support and involvement in the community.
- Chemical dependency evaluations and treatment to needy offenders.
- Mental Health evaluations and counseling services to needy individuals.
- Surveillance of offender activities in the community to ensure public safety is maintained.

# Completing Intensive Supervision Successfully

## Introduction

If you are reading this pamphlet, this means that you have been placed on intensive supervised probation by the court system of the State of Kansas. This pamphlet was created to explain what is expected of you in order to avoid any possible jail or prison time. Please pay attention to the information provided. It could mean the difference between success and failure while under supervision.

## Supervised Probation

As a result of your conviction for a criminal offense, the court has placed you on intensive supervised probation. The judge has ordered that you spend a specific amount of time on probation while complying with certain conditions. These conditions have been ordered to assist in improving your behavior and to ensure the safety of the community. Failure to comply with these conditions may result in a violation hearing before the court and may have consequences such as jail or prison time.

You will be assigned a community corrections officer after a brief intake process the day you are in court. At your first appointment, your officer will review the court judgment with you. The officer will explain how much jail or prison time you face if you fail at probation, how much time you are ordered to spend on probation, all regular and special conditions of probation and any monies you must pay to the court and community corrections.

**The most important condition of all is the contact and communication between you and your community corrections officer. You are required to meet with your officer as specified at a date, time and frequency set by the officer.**



## Regular Conditions of Probation

One of two types of conditions you must abide by while on intensive supervised probation is called a regular condition. These conditions are the same for everyone on probation and include:

- Obey all laws of the United States, the State of Kansas and any other jurisdiction which you are subject.
- Report to the community corrections officer as directed.
- You are required to make payments to the court as indicated (court costs, attorney fees, restitution, probation fee, fines, and other).
- Community service work requirements.
- Avoid such injurious or vicious habits as directed by the court or community corrections officer.
- Work faithfully at suitable employment as far as possible.
- Keep your community corrections officer informed of your home and current phone number always and remain within the area specified.
- Do not illegally possess, use or traffic any illegal drugs. Refrain from the use of alcohol.
- Allow the community corrections officer to visit you at home or elsewhere.
- Obey your community corrections officer implicitly in all terms and directives.
- Reside in a residential facility, whether located within or outside the community, to participate in education, counseling, or other rehabilitative programs.
- Curfew, house arrest, and/or electronic monitoring.

## Special Conditions of Probation

The second type of condition that you must abide by while on intensive supervised probation is called a special condition. Special conditions are those conditions that are specific to your case, and may or may not be the same for someone convicted of the same offense. Because circumstances in your case are different from someone else, so are the special conditions of probation. Special conditions are many, but mostly include:

- Administrative sanctions that may be imposed at the discretion of the community corrections officer for minor and procedural violations of the Intensive Supervision Probation Agreement.
- You will be required to comply with and successfully complete all conditions as set forth in the Pre-sentence Investigation Report.

Your community corrections officer will add all of your court costs and divide them by the amount of time you are on probation. This is the amount you must pay to the district court clerk each month in order to pay all the costs owed as ordered. As well, the officer will advise you of the program, supervision and related fees that you will be required to pay to community corrections during the period of supervision.

## Violating Probation

All conditions are important. You are expected to follow all conditions and the directions given by your officer. By failing to abide by any condition you violate your probation, and the consequences may be, but not limited to, one or more of the following:

- a verbal reprimand,
- community service,
- increased reporting, home visits, surveillance contacts,
- electronic monitoring,
- mandatory participation in treatment and/or a cognitive program,
- jail time, and
- revocation (serve your prison sentence).

**You are reminded that the court may at any time revoke your intensive supervision status for cause, modify the conditions of intensive supervision and reduce or extend the period of supervision as provided by law. The court may issue a warrant for your arrest or the community corrections officer may arrest you without a warrant for violations of the terms and conditions as set forth in the journal entry of sentencing and as further defined in the supervision agreement.**
