COMMUNITY CORRECTIONS AND REHABILITATIVE SERVICES

ASSESSMENTS AND PROGRAMS OVERVIEW

Assessments

Domestic Violence Assessment (DVI) –

The DVI consists of the client answering 155 questions, which are scored by a computer, a personal history, brief personal interview and a review of supporting documentation, if available. The DVI assesses client's needs in the areas of truthfulness, alcohol, control, drugs, violence and stress coping skills. The assessment is offered in English and Spanish. (Cost is \$60.00 and due at the time of the assessment.)

Crossroads Assessments (SAQ) –

The SAQ consists of the client answering 149 questions, which are scored by a computer, a personal history, brief personal interview and a review of supporting documentation, if available. The SAQ assesses client's needs in the areas of truthfulness, alcohol, drugs, violence, antisocial behavior, aggressiveness and stress coping skills. The assessment is offered in English and Spanish. (Cost is \$60.00 and is due at the time of the assessment.)

Substance Abuse Evaluation –

Consists of personal interview to obtain current pertinent bio-psycho-social information, Addiction Severity Index (ASI) instrument, Substance Abuse Subtle Screening Inventory-3 (SASSI-3), Alcohol Use Profile (AUP) and a review of supporting documentation if available. This assessment determines the client's need for substance abuse treatment and/or what level of treatment is appropriate. The evaluation is offered in both English and Spanish. (Cost is \$75.00 and is due at the time of the assessment.)

Alcohol/Drug Safety Action Program (ADSAP) –

Required by law for clients charged with DUI in the State of Kansas. Similar to a substance abuse evaluation and includes a factual basis of the circumstances, the client's BAC and case information. The assessment is offered in both English and Spanish. (Cost is statutorily set at \$150.00 and is due at the time of the assessment.)

Programs

Batterers' Intervention Program (Domestic Violence) –

A 6 weeks cognitive-behavioral group education program for individuals whose results on the DVI indicate that they would benefit from participation and/or as directed by the court or a condition of supervision. The program

offers the client an opportunity to learn new skills to deal with interpersonal relationships and help cope with the stress that many times accompanies intimacy. Some of the topics covered are: domestic violence, the cycle of violence, relationships, communication skills, problem solving skills, conflict avoidance skills, responsibility, stress management and consequences. This group is for male participants only and generally runs for a period of 6 weeks for about 2 hours per group. The group is offered in both English and Spanish. (Cost for the 6 weeks program is \$180.00—\$150.00 plus \$30.00 for a workbook—and is due prior to entering the program.)

Anger Management Program –

A 6 weeks cognitive-behavioral group education program that addresses issues leading to violent behavior and focuses on alternatives to those behaviors. Topics include but are not limited to: communication skills, trust, stress management, high-risk behaviors and respect. This generally runs for a period of 6 weeks for about 2 hours per group. The group is offered in both English and Spanish. (Cost for the 6 weeks program is \$180.00—\$150.00 plus \$30.00 for a workbook—and is due prior to entering the program.)

Crossroads Program (Life Skills) –

A 50 hours cognitive-behavioral group education program for individuals whose results on the DVI or SAQ III indicate they would benefit from participation and/or as directed by the court or a condition of supervision. This program also offers the client the opportunity to learn new skills to help cope with the stresses of everyday life and competencies to better work within their environment. This program covers topics such as: communication, goals, attitudes and behaviors, finances, trust, alcohol and drugs, consequences, victimization, conflict, control, violence, and relationships. The group consists of both males and females and generally runs for a period of 16 weeks for about 3 hours per group. The program is offered in both English and Spanish. (Cost for the 16 weeks program is \$260.00—\$200.00 plus \$60.00 for a workbook—and is due prior to entering the program.)

Larceny Program –

An 8 hours cognitive-behavioral education program for clients that deprived another of their property. This program demonstrates how attitudes can override a person's sense of right and wrong and cause them to act contrary to their basic beliefs. It offers the client the opportunity to understand and accept their mistake and the resources to help them never repeat the act again. The program covers topics such as: choices and consequences, the act of and rationalizations for stealing, contributing factors, victimization, values, attitudes and behaviors. The program is offered in both English and Spanish. (Cost for the 8 hours program is \$120.00—\$100.00 plus \$20.00 for a workbook—and is due prior to entering the program.)

Level I Outpatient Treatment for Substance Abuse –

This program is a variable length substance abuse treatment program, licensed by the State of Kansas. The program also has variable levels of intensity based on the client's needs as determined by a substance abuse evaluation or ADSAP. The program consists of both groups and individual counseling sessions. The certified counselor provides information about different types of drugs/alcohol, addiction, dependence and abuse. It explores the different methods to achieve abstinence, attending support groups, problem solving skills, stress management, AIDS/HIV information, and dealing with the signs of relapse. This is a continuous program that clients can enter after obtaining a substance abuse evaluation referring them for outpatient treatment and, then, completing an intake with our agency. Additionally, the Chronic Abuser Program is more intensive program available for clients that need more than a basic Level I program can provide. These are clients that continue to use or abuse alcohol and drugs, clients that are on waiting lists to get into inpatient treatment, or clients that have such severe substance abuse histories that placement in a Level I program may not serve all of their needs. The treatment is offered in both English and Spanish. (Cost for all Substance Abuse Treatment Services is \$20.00 per hour.)

Women's Program –

This program is also a substance abuse treatment program similar to the Level I Outpatient Treatment described above that has been specifically designed to address many issues that are often avoided by females in co-ed groups. Some of the topics addressed are Anger, Childhood Abuse Issues, Domestic Violence, Fear, Grief, Decision Making, Denial, Depression, Family Issues, Setting Goals, Parenting, Peer Pressure, Relapse Prevention, Relationships, Self-Esteem/Respect, Co-Dependency, Stress, Substance Abuse, Pregnancy and Life Skills. (Cost of all Substance Abuse Treatment Services is \$20.00 per hour.)

Alcohol/Drug Information School (A/DIS) –

This program is an 8-10 hour drug and alcohol education program for clients with minimal drug and alcohol histories. It is required as a mandatory minimum for people convicted of DUI. The class is offered in English and Spanish and is held monthly. (Cost for the program is \$120.00 and is due at the time of service.)

Employment Program –

This program is designed specifically for Community Corrections clients who may have a difficult time gaining employment. The program coordinator is a trained individual that will assist the offender in obtaining the skills and tools necessary to seek employment, apply for employment, obtain employment and finally maintain employment. Some aspects of the program consist of resume writing, interview coaching, completing applications, interpersonal communications skills, appearance and hygiene assessment, strategies to discuss convictions and incarcerations and employer testing. This program

has a maximum length of eight 8 weeks. (Cost for the program is \$25.00 plus the actual costs of materials and supplies needed for employment.)

Menu Program –

The menu program is a collection of brief educational classes that are provided in both group and individual modalities. The concept behind the menu program is to provide specifically targeted cognitive pro-social education for clients that have limited social competency and lack the skills to manage the resulting problems that lead to condition violations and/or continued criminal behaviors. This education will provide the client with a clear and socially appropriate understanding of the following topics: Budgeting and Money Management, Healthy Relationships, Self-Esteem and Self-Discovery, Anger management, Conflict and Conflict Resolution, Choices/Priorities/Goals and Objectives, Theft Education and DWS Information School. The length of each topic will vary in length from 1 hour to 4 hours. (Cost is \$20.00 per hour of instruction and is due at the time of service.)

Alcohol and/or Drug Testing –

Clients that are on diversion, probation (supervised or unsupervised) and awaiting trial may be tested for substance use. Arrangements must be made for each client prior to reporting for a supervised substance testing. The client must pay for drug testing prior to the test taking place. If a client's test result is positive, they can admit to usage for free or they can request to have the sample sent for GCMS confirmation. If GCMS confirmation is requested, the client must pay a \$35.00 fee per drug prior to sending the sample to the lab. The failure of the client to comply with these conditions is the responsibility of the referral source. (Cost for a 3 or 5 panel drug screen is \$15.00 and \$1.50 for a PBT.)
